WHODrug Global March 2022 version now available

The March 2022 version of WHODrug Global is now available. It can be downloaded from the WHODrug Download Area (by designated delivery contacts only) and accessed via WHODrug Insight, both available in the WHODrug User area. The March 2022 version of the WHODrug Global dictionary contains over 580,000 drug names from 167 countries.

This document outlines the most important developments and revisions to the content of WHODrug. Topics covered include ATC alterations, general substance changes, and developments of the WHODrug Standardised Drug Groupings (SDGs).

Reminder: Changes to the WHODrug product files and modified packaging


As previously announced, in the March 2022 release of WHODrug Global three modifications to the WHODrug Global files have been rolled out to meet evolving regulatory expectations and technical developments. Read more about the modifications below or on the <u>UMC website</u>:

- The substance name field has been extended to **250 characters** in both the B3 and C3 formats, to accommodate a more granular naming of substances.
- The casing of **drug names in the C3** format has been unified to standardise the appearance of drug names bearing the same drug code.
- The country codes and country names have been updated for a few countries, to harmonise with the ISO
- 3166-1 standard. • The WHODrug Global files have been **split into two file packages** to enable a faster and smoother download
- experience: WHODrug Global 2022 Mar 1, and WHODrug Global Chinese 2022 Mar 1.


